- The Contractor shall maintain automobile liability insurance in an amount not less than \$1,000,000 per occurrence to protect against liability arising from the use, loading, and
- unloading of all of the Contractor's owned, hired, and non-owned automobiles in connection with this project.
- The Contractor shall maintain workers' compensation coverage for all subject workers as required by law, including employer's liability.
