#### 1. Introduction

The Mason County Economic Development Council and Kitsap Economic Development Alliance are seeking proposals from qualified consultants to conduct an Economic Impact Study evaluating the current and potential economic contributions of a regional sewer system serving Belfair, Washington and the southern portion of the Puget Sound Industrial Center (PSIC) in the City of Bremerton, Washington.

The study will assess both the direct, indirect, and induced contributions of the sewer system to regional economic development and will specifically analyze the impacts on small businesses operating in Belfair and Bremerton.

# 2. Background

Belfair is an unincorporated community in Mason County, Washington, with a diverse small business sector serving local residents, tourists, and commuters. The Puget Sound Industrial Center (PSIC) in Bremerton is a designated regional manufacturing and industrial hub with growing infrastructure and workforce needs.

The regional sewer system connecting Belfair and PSIC South represents a critical infrastructure investment with potential to:

- Expand business and industrial capacity
- Support small business growth and retention
- Enable new development opportunities
- Protect environmental quality and public health

An economic study is needed to help local governments, utilities, businesses, and community stakeholders understand the system's contributions and to inform policy and funding decisions.
