The Texarkana Independent School District is soliciting competitive sealed proposals for vendors to supplement District employed workers on an as needed basis during the approximate five year period, April 18, 2021 to April 30, 2026. The jobs will vary throughout this time period and there is no guarantee of any set amount of work that may be performed under this contract. The jobs could range from as simple as installing a new plug, replacing a compressor capacitor, cleaning out a drain line to as complicated as remodeling an entire campus or a particular part of a new construction project. The District will award this proposal based on an hourly rate and a discount off published pricing for material, parts, and equipment supplied by the vendor. In some instances equipment and parts may be provided by the District.

All interested vendors should complete the labor/discount sheets, answers to evaluation questions below, and other required forms and return, sealed, by the initial opening deadline for consideration and possible award by our Board of Trustees at their regular March 2021 meeting. Vendors should also include in their response a detailed description of all of the licenses that they hold, liability insurance amounts, workmen's compensation amounts, and a list of references. Any information an interested vendor could supply regarding their company would be helpful in determining the best vendor to award this contract.

Texarkana ISD does reserve the right to accept or reject any and/or all proposals and to award the proposal to the vendor that best meets the needs of the District. Texarkana ISD reserves the right to seek quotes amongst awarded vendors, or solicit proposals, or use cooperative contracts for large one time jobs during this contract period or to comply with federal or state procurement requirements.

Interested vendors should propose an hourly rate that they will charge the District for the various classifications of workers that they have. Vendors should propose a percent discount off their published pricing list for the supplies when they are used. All other possible hourly charges or fees that a vendor could foresee charging to the Texarkana Independent School District must be included in their proposal. This contract will be cancelable by either party, for any reason, with thirty days written notice.

After award, any change to terms or conditions must be mutually agreeable by the District and the vendor and must be in writing and approved by the Director of Purchasing.

The following criteria will be used in determining the vendor to award the contract to:

- a. the purchase price; 30 points**
- b. the reputation of the vendor and of the vendor's goods or services and quality of the vendor's goods or services; 25 points**
- c. the vendor's past relationship with the district; 10 points**
- d. the impact on the ability of the district to comply with laws and rules relating to historically underutilized businesses; 5 points**
- e. Proposed Personnel; 10 points**

f. Financial Capability; 10 points

g. Safety Record; 10 points

Total possible points **100**.

- 1) List past relationship with the District up to prior fifteen years.
- 2) Provide (no more than one page per project front/back) the last three projects in similar size/scope you have completed most recently and describe the quality of these projects. Photos may be submitted. Please provide reference contact information of owner for each project.
- 3) Provide a list of proposed key personnel along with their experience, education, and special qualifications. Include key personnel of proposed subcontractors in this list also.
- 4) State your financial capability to perform a project. Please list any bankruptcy filings your company has had in the last 5 years, provide most recent financial statement, and provide any proposed financing you have arranged for a project.
- 5) List your current workman's compensation experience modifier rate. List safety record for last 5 years. List any current or proposed litigation or inquiry against your company involving worker safety. Describe your safety plan for this project (no more than one page).
- 6) Is your company a registered HUB vendor with the State of Texas? If so, please provide your certificate.

Texarkana Independent School District Certificate of Interested Parties – Form 1295

The District is required to comply with House Bill 1295, which amended the Texas Government Code by adding Section 2252.908, Disclosure of Interested Parties. Section 2252.908 prohibits the District from entering into a contract resulting from this RFP with a business entity unless the business entity submits a Disclosure of Interested Parties – Form 1295 to the District at the time the business entity submits the signed contract. The Texas Ethics Commission has adopted rules requiring the business entity to file Form 1295 electronically with the Texas Ethics Commission.

**REQUIRED CONTRACT PROVISIONS FOR NON-FEDERAL ENTITY CONTRACTS UNDER FEDERAL AWARDS
APPENDIX II TO 2 CFR PART 200**

(A) Contracts for more than the simplified acquisition threshold currently set at \$250,000, which is the inflation adjusted amount determined by the Civilian Agency Acquisition Council and the Defense Acquisition Regulations Council (Councils) as authorized by 41 U.S.C. 1908, must address administrative, contractual, or legal remedies in instances where contractors violate or breach contract terms, and provide for such sanctions and penalties as appropriate.

Pursuant to Federal Rule (A) above, when TISD expends federal funds, TISD reserves all rights and privileges under the applicable laws and regulations with respect to this procurement in the event of breach of contract by either party.

TISD also reserves the right to terminate the contract immediately, with written notice to vendor, for convenience, if TISD believes, in its sole discretion that it is in the best interest of TISD to do so. Vendor will be compensated for work performed and accepted and goods accepted by TISD as of the termination date if the contract is terminated for convenience of TISD. Any award under this procurement process is not exclusive and TISD reserves the right to purchase goods and services from other vendors when it is in TISD's best interest.

(C) Equal Employment Opportunity. Except as otherwise provided under 41 CFR Part 60, all contracts that meet the definition of "federally assisted construction contract" in 41 CFR Part 60-1.3 must include the equal opportunity clause provided under 41 CFR 60-1.4(b), in accordance with Executive Order 11246, "Equal Employment Opportunity" (30 FR 12319, 12935, 3 CFR Part, 1964-1965 Comp., p. 339), as amended by Executive Order 11375, "Amending Executive Order 11246 Relating to Equal Employment Opportunity," and implementing regulations at 41 CFR part 60, "Office of Federal Contract Compliance Programs, Equal Employment Opportunity, Department of Labor."

Pursuant to Federal Rule (C) above, when TISD expends federal funds on any federally assisted construction contract, the equal opportunity clause is incorporated by reference herein.

(D) Davis-Bacon Act, as amended (40 U.S.C. 3141-3148). When required by Federal program legislation, all prime construction contracts in excess of \$2,000 awarded by non-Federal entities must include a provision for compliance with the Davis-Bacon Act (40 U.S.C. 3141-3144, and 3146-3148) as supplemented by Department of Labor regulations (29 CFR Part 5, "Labor Standards Provisions Applicable to Contracts Covering Federally Financed and Assisted Construction"). In accordance with the statute, contractors must be required to pay wages to laborers and mechanics at a rate not less than the prevailing wages specified in a wage determination made by the Secretary of Labor. In addition, contractors must be required to pay wages not less than once a week. The non-Federal entity must place a copy of the current prevailing wage determination issued by the Department of Labor in each solicitation. The decision to award a contract or subcontract must be conditioned upon the acceptance of the wage determination. The non-Federal entity must report

all suspected or reported violations to the Federal awarding agency. The contracts must also include a provision for compliance with the Copeland "Anti-Kickback" Act (40 U.S.C. 3145), as supplemented by Department of Labor regulations (29 CFR Part 3, "Contractors and Subcontractors on Public Building or Public Work Financed in Whole or in Part by Loans or Grants from the United States"). The Act provides that each contractor or subrecipient must be prohibited from inducing, by any means, any person employed in the construction, completion, or repair of public work, to give up any part of the compensation to which he or she is otherwise entitled. The non-Federal entity must report all suspected or reported violations to the Federal awarding agency.

Pursuant to Federal Rule (D) above, when TISD expends federal funds during the term of an award for all contracts and subgrants for construction or repair, Vendor will be in compliance with all applicable Davis-Bacon Act provisions.

(E) Contract Work Hours and Safety Standards Act (40 U.S.C. 3701-3708). The requirements of 40 U.S.C. 3704 are applicable to construction work and provide that no laborer or mechanic must be required to work in surroundings or under working conditions which are unsanitary, hazardous or dangerous. These requirements do not apply to the purchases of supplies or materials or articles ordinarily available on the open market, or contracts for transportation or transmission of intelligence.

Pursuant to Federal Rule (E) above, when TISD expends federal funds, Vendor certifies that Vendor will be in compliance with all applicable provisions of the Contract Work Hours and Safety Standards Act during the term of an award for all contracts by TISD resulting from this procurement process.

- (3) The undersigned shall require that the language of this certification be included in the award documents for all covered sub-awards exceeding \$100,000 in Federal funds at all appropriate tiers and that all subrecipients shall certify and disclose accordingly.

As described in Public Law 115-232, section 889, covered telecommunications equipment is telecommunications equipment produced by Huawei Technologies Company or ZTE Corporation (or any subsidiary or affiliate of such entities).

- (i) For the purpose of public safety, security of government facilities, physical security surveillance of critical infrastructure, and other national security purposes, video surveillance and telecommunications equipment produced by Hytera Communications Corporation, Hangzhou Hikvision Digital Technology Company, or Dahua Technology Company (or any subsidiary or affiliate of such entities).
 - (ii) Telecommunications or video surveillance services provided by such entities or using such equipment.
 - (iii) Telecommunications or video surveillance equipment or services produced or provided by an entity that the Secretary of Defense, in consultation with the Director of the National Intelligence or the Director of the Federal Bureau of Investigation, reasonably believes to be an entity owned or controlled by, or otherwise connected to, the government of a covered foreign country.
- (b) In implementing the prohibition under Public Law 115-232, section 889, subsection (f), paragraph (1), heads of executive agencies administering loan, grant, or subsidy programs shall prioritize available funding and technical support to assist affected businesses, institutions and organizations as is reasonably necessary for those affected entities to transition from covered communications equipment and services, to procure replacement equipment and services, and to ensure that communications service to users and customers is sustained.

Pursuant to the Federal Rules above, vendor certifies that it will not enter into a contract with the District to provide any of the prohibited equipment listed above.

(L) §200.322 Domestic preferences for procurements.

The requirements of this section must be included in all subawards including all contracts and purchase orders for work or products under this award.
- (b) For purposes of this section:
 - (1) "Produced in the United States" means, for iron and steel products, that all manufacturing processes, from the initial melting stage through the application of coatings, occurred in the United States.
 - (2) "Manufactured products" means items and construction materials composed in whole or in part of non-ferrous metals such as aluminum; plastics and polymer-based products such as polyvinyl chloride pipe; aggregates such as concrete; glass, including optical fiber; and lumber.

Pursuant to the Federal Rule above, vendor certifies that it will, to the greatest extent practicable, enter into contracts with the District with items produced within the United States, as outlined above, and will include this requirement in any sub-awards for any District contract that is entered into.
